#### 1.1 Introduction

The Department of National Planning was originated as the National Planning Council in 1956 under the Chairmanship of the Prime Minister and as a turning point of the planning history of the country, for the first time a detailed and integrated development plan was prepared by the council covering entire country. In 1961, the council was strengthened and converted into a Planning Department under the Prime Minister's Office. This Department prepared a short – term development programme and introduced the concept of rolling plans to the planning process. Later, the Department was attached to Ministry of Planning and Economic Affairs in 1965 and assigned preparation of the capital budget, coordination of the implementation of development activities and monitoring. In 1974, the National Planning Department was brought under the Ministry of Finance and Planning and since then, it was attached to the Ministries which are responsible for Finance, Planning and Policy Development from time to time by the successive governments. At present, as the most competent development advisor and facilitator to the nation, the Department delivers its functions in accordance with the authority delegated by the Financial Regulations No: 3(2) and No: 35.

#### Sector wise progress and the Future Outlook

#### 2.1 Macro-Economic Sector

The Macroeconomic Division aims to assist the other sectors of the department in translating national development priorities and policies into implementable projects and programmes. It analyses national and international context and provide inputs to other sectors for the preparation of sectoral strategies and review sectoral plans.

#### **Progress**

- Completed initial work in updating Public Investment Programme (PIP) 2019-2021.
- Prepared box article for Annual Report 2018 of Ministry of Finance.
- Collection and submission of required information on Public Investment Programme 2019-2021 to the Central Bank Annual Report 2018.

#### 2.2 Agriculture, Irrigation, Land, Livestock and Fisheries

#### **Agriculture Sector**

The agriculture sector still is the backbone of Sri Lankan economy even though the share of GDP decreases significantly. Currently, the government is expected to modernize the agriculture sector towards highly productive, technology driven, sustainable and highly profitable sector while increasing competitiveness of the agro based products in the international market with

assured food safety standards within next 5 years. In line with that the government initiated several measures during the last year. Formulation of the Overarching Agriculture Policy covering all the subsectors is one of the key action initiated by the government to address the issues experienced in market linkages, governance and agricultural service delivery.

#### **Crop Agriculture**

Crop agriculture constitutes of paddy, vegetables, other field crops (OFCs), fruits, export agricultural crops including spices, floriculture & foliage plants. The government has taken several initiatives to ensure and strengthen the resilience in crop agriculture production as well as the competitiveness of its exports. Among these initiatives, development of Good Agricultural Practices (GAP) Strategy to be promoted the production of healthy food products for consumption and the export was significant and this is one of major achievement in the sector. There is an urgent and increasing need to assure safe and quality agricultural foods for local consumers, and to access global market opportunities by meeting the safety and quality standards of international requirement to trade. GAP, a guaranteed certified system, is one of the ideal identification to prove the proper use of agrochemicals and minimizing negative impacts to the human health and environment. Accordingly, around 12 billion had been allocated for the crop agriculture development as the capital investment during 2019.

#### Tasks completed by the agriculture sector of NPD

- Appraised 23 project proposals and submitted observations to the Department of National Budget and the Department of External Resources.
- Submitted 18 Cabinet observations for the Cabinet Memoranda forwarded by Ministey of Agriculture, Rural Economic Affairs, Livestock Development, Irrigation and Fisheries & Aquatic Resources Development then Ministry of Agriculture
- Involved in providing technical inputs and policy directives together with all relevant stakeholders to formulate the Overarching Policy for Agriculture sector.

#### **Irrigation and Land Sector**

Total expenditure of the irrigation sector in 2019 amounted to Rs.45.51 bn. of which Rs. 38.79 bn was on capital expenditure. Under New Water Resources Development, large scale development programmes have been continued such as Mahaweli Water Security Investment Programme, Yan Oya Reservoir Project, Kaluganga reservoirs project, Kalugal Oya Reservoir project, Morana reservoir project, Uma Oya Multi-purpose Development project and Climate Resilience and Improvement Project. A number of rehabilitation projects have also been undertaken to provide water for agriculture and the other water uses.

Total expenditure of Land sector in 2019 amounted to Rs. 8,644 Mn of which Rs. 3,172 Mn was on capital expenditure. In 2019, a significant amount of expenditure has been made in land title programme (Bimsaviya) as well. Further, lands were identified and acquired for state development programmes during 2019.

#### Livestock

The Livestock sector mainly comprises with diary, poultry, swine, goat and sheep sub sectors and plays a multiple role in the country's economy through supporting rural economy and ensuring food and nutrition security for the people. The sector has mainly targeted on making available livestock products at affordable prices while generation more employment and increasing income as livestock enterprises. The public investment in this sector in 2019 was mainly for the establishment of Dairy Processing Plant, development of Mini Dairy Cooperative Societies, livestock health improvement and breeding programmes and research & capacity development activities.

- Appraised 03 project proposals and submitted observations to the Department of National Budget and to the Department of External Resources.
- Submitted 03 Cabinet observations for the Cabinet Memoranda forwarded by the relevant ministries.

#### **Fisheries**

The Fishery sector plays vital role in the economy in terms of providing livelihoods for more than 2.6 mn people and ensuring the food security of people. At present 53% of annual protein requirement is supplemented by fish and fish products. The public investment in this sector was allocated mainly to develop fisheries infrastructure including harbours, anchorages and landing sites, introduction of modern technology, increase inland and aquaculture fish production, research and development and to empower fishing community in 2019.

- Appraised 07 project proposals and submitted observations to the Department of National Budget and Department of External Resources
- Submitted 04 cabinet observations for the Cabinet Memoranda forwarded by the Ministry of Fisheries and Aquatic Resources Development

#### 2.3 Industry, Trade and Power & Energy

The industry, trade and investment sectors have been identified as important strategic sectors in the economy. Hence, the Department of National Planning provides necessary policy inputs to strengthen the Industries, Small and Medium Enterprises, State Own Enterprises, International Trade and Foreign Direct Investment. Also, involve in pre-evaluation process for the sector

related projects proposals while intervene to the sectoral financing. Having identified the necessity of the country, following activities were completed during 2019.

- Appraised 49 project proposals and submitted recommendations to the Department of National Budget, Department of External Resources and Relevant Line Agencies.
- Submitted observations for 07 Cabinet Memoranda presented by the line Ministries.
- Assisted for updating Public Investment Programme (PIP) 2018-2021 by providing relevant information of the Industry sector.
- Contribute to the sector policy in formulating the National Policy Framework for the "Vistas of Prosperity and Splendour"
- Provide sectoral inputs to achieve Sustainable Development Goals 2030.

#### **Labour and Foreign Employment**

Labour and foreign employment policies intend to protect and foster rights of the employees who contribute to the national economy by engaged in local and foreign employment through increasing remittances. This Policy intends to develop a long term vision for the role of labour migration in the economy, enhancing the benefits of labour migration to the development of the country while protecting the rights of the migrant workers.

While enforcing existing laws and regulations, all necessary reforms need to be made to meet the emerging circumstances and to bring them in line with international best practices. Having identified this need, the following activities were completed during 2019.

- Appraised 06 project proposals submitted by the line agencies and submitted recommendations to the Department of National Budget and Department of External Resources.
- Submitted observations for 05 Cabinet Memoranda presented by the line Ministries.
- Assisted for updating Public Investment Programme (PIP) 2018-2021 by providing relevant information of the Industry sector.
- Contribute to the sector policy in formulating the National Policy Framework for the "Vistas of Prosperity and Splendour"
- Provide sectoral inputs to achieve Sustainable Development Goals 2030.

#### **Power and Energy Sector**

Power and Energy sector represents electricity and the petroleum industries. Both these industries are largely managed by state-owned enterprises. While the private sector participation is very much less in the electricity sector and it is comparatively high in the petroleum sector. Sri Lanka's per capita electricity consumption was 650 kWh/person in 2018 and this is continuing to

increase. With the expected economic growth, demand for the power and energy sector from the industry and services sectors will also be continued to increase. Necessary actions are needed to be taken to meet this rising demand in the power and energy sector.

The recent trend of developing renewable energy sources has promoted by the government as well. Accordingly, power generation sources range from conventional sources such as coal, natural gas, hydro and oil to non-conventional sources such as solar, wind, ocean wave, geothermal and biomass. The Department of National Planning (NPD), has also given its fullest cooperation for developing power and energy sector without violating the "carbon neutrality" of the sector. In 2019, the contribution of the NPD could be summarized as below.

- The Department of National Planning appraised and provided observations for 14 project proposals
- Provided observation for 4 Cabinet Memoranda, including the Cabinet Memoranda on "National Energy Policy and National Policy of Natural Gas"
- Provided observations to the matters related to the foreign missions
- Worked on the committees on the nuclear power development program in Sri Lanka
- Provided technical support in the preparation of the National Policy of Natural Gas
- Provided comments at the "Public consultation on National Policy on Natural Gas and its implementation strategies"

#### 2.4 Transport, Highways, Ports and Aviation

These sectors mainly aim to provide efficient transport services to movement of passenger and goods within the country and with the rest of the world. During 2019, the main areas for investments include expressway development, road widening and rehabilitation, maintenance of roads and bridge construction, promoting public transportation through modernization, enhancing urban rural connectivity, reducing urban traffic congestion, reducing the incidence of road accidents and expansion of port and airport infrastructure and facilities.

#### 2.5 Urban Development, Housing, Water and Environment Sector

#### **Urban Development and Housing**

The Urban Development and Housing sector works with the relevant line Ministries to provide policy and strategic guidelines for establishing urban infrastructure in the country, streamlining existing facilities and for improving housing facilities.

Substantial contributions to the economy of a country are made by urban areas where economic potential is compounded. A considerable proportion of the population of our country has already been living in urbanized areas. However, due to the lack of appropriate established criteria measure the urbanization, it is difficult to correctly estimate the percentage of urbanization. Recognizing the potential for development in the city is critical for the proper placement of future investments. As such, establishment make up of urban cities need to be systematic, interrelated and accessible to mitigate the hindrances to sustainable urbanization and to facilitate the proper function of the economy.

Out of 6 million families of the country only 5.2 million have a house of some form. Therefore, the number of families without a house of their own are over 800,000. The magnitude of the problem is further intensified as nearly 300,000 of the current housing stock are just temporary assemblies.

Therefore, this sector makes contribution in identifying the projects that facilitate the proper development of urban areas and housing in order to create sustainable urbanization, sustain economic development, enhance the quality of life by improving housing facilities, and formulates required policies.

- Conducting consultations with stakeholders to resolve issues identified in various projects implemented by the respective line ministries, and aligning them with national development agenda by contributing to the correct identification of development needs
- Conducting workshops to educate line agencies
- Providing necessary technical assistance to relevant line ministries and agencies for preparation of policies and strategies

#### Water Supply & Sanitation

Providing safe drinking water and improved sanitation is essential prerequisite to improve living standards of the people and socio economic development of the country. The Department of National Planning is closely working with the Ministry of City Planning, Water Supply and Higher Education, National Water Supply & Drainage Board, Department of National

Community Water Supply and other relevant sectoral stakeholders and involving sector development activities by providing necessary policy inputs and guidance to these institutions with regard to formulation sectoral policies and implementation of projects and programmes. During the year, the following sector specific tasks and activities have been completed with regard to the water supply and sanitation sector.

- Participated 20 meetings with foreign missions as kick-off, portfolio review and wrap-up meetings related to the ongoing and proposed development projects in the sector.
- Participated the project Steering Committee meeting of water supply & sewerage projects.
- 5. Public Investment Programme Updating the public investment programme of water and sanitation sector for the period of 2019-2021.
- 6. Master plan of the water and sanitation sector- preparation of Master Plan for the water and sanitation sector is ongoing and NPD has given its contribution by participating several workshops and meetings.

#### Environmental & Disaster Management

Environmental management is to facilitate a robust economic growth through required investments while taking measures to ensure the quality of environment leading to sustainable development. Green development is the key word of the environment policy which embraces a pollution-free environment and a toxin-free food habit. The environment sector aims at achieving low carbon, clean and green environment through the reduction of pollution, protection of rich biodiversity and ecosystem services, reduction of environment risk and efficient, sustainable resource consumption resulting in improved human well-being, environmental quality and reduced natural disaster impacts. It is obvious that the environmental management is of paramount importance in achieving sustainable development. Hence, in development planning it is necessary to pay due attention to conserving biodiversity and ecosystems which is essential to maintain the ecological balance.

The frequency of having natural disasters is higher in the country and therefore, it automatically leads to higher damages and losses. Therefore, the Government has taken several steps in terms of managing disasters in order to facilitate harmony, prosperity and dignity of human life through effective prevention and mitigation of natural and man-made disasters in the country.

- Appraised 12 project proposals relevant submitted by relevant line ministries
- Provided observations to 14 Cabinet Memoranda submitted by relevant line ministries
- Assisted in updating the Public Investment Programme 2019-2021 (Draft)

#### 2.6 Health & Indigenous Medicine, Sports, Culture and Religious Affairs

#### **Health Sector**

At present, nearly 50% of the outpatient treatment, 90% of the inpatient care and 99% of the preventive care needs are provided by the public health system. However, in order to face the growing healthcare needs of Non Communicable Diseases, elderly care and communicable diseases such as tuberculosis and dengue, improving efficiency and quality of the public healthcare system is vital. Therefore, government has initiated several policy reforms and increased investment on development of healthcare facilities. During the year 2019, NPD completed following tasks in respect of Health Sector to achieve said goals.

- Seventeen project proposals were recommended for implementation. The observations were submitted to the Department of National Budget, Department of External Resources and to the relevant line agencies.
- Prepared Cabinet Observations for 8 Cabinet Memoranda submitted by the Ministry of Health, Nutrition & Indigenous Medicine.
- Conducted several meetings and provided observations/ inputs to officials of WHO, World Bank, KOICA, JICA etc. to obtain financial assistance for the implementation of foreign funded projects, relating to the health sector.
- Trained officials from the Ministry of Health, Nutrition & Indigenous Medicine to develop project proposals in line with the New Project Submission Format at the Workshop on "New Project Submission Format for Development of Project Proposals for relevant officers" on 05.07.2019 at Bandaranaike Memorial International Conference Hall.
- Updated public investment programme on Health sector for the Medium Term Budgetary Framework 2020 2022.

#### Religious, Cultural and Social Integration Sector

During the year 2019 the government invested on Religious, Cultural and Social Integration sector to buildup spiritual developed and harmonized society through facilitating variety of development projects. The areas covered by this sector are Buddhism, Hindu, Christianity and Muslim, Cultural, Heritage, National Archives, National Museums, Official Languages and Social Integration.

During the year 2019 following actions had been taken by the NPD regarding above sectors.

• Appraised 13 project proposals.

- Submitted observations for one Cabinet Memoranda and comments submitted for one Cabinet Memoranda.
- Trained officials from Religious, Cultural and Social Integration sectors to develop project proposals as per the New project Submission Format 2019 at the Workshop on "New Project Submission Format for Development of Project Proposals for Government Officers and Planners" on 05. 07. 2019 at Bandaranayake Memorial International Conference Hall, Colombo.
- Updated the project pipeline on Religious, Cultural and Social Integration sectors for 2019-2021 medium term budgetary frame work and participated meetings relating to Religious, Cultural and Social Integration sector.

#### **Sports Sector**

During the year 2019, the government invested on sports sector targeting to improve necessary infrastructure facilities, as well as produce healthy nation covering entire population which leads to reduce government expenditure on Non Communicable Diseases (NCD) and develop the economy and make sports as an integral part of country's culture and society.

The following tasks were completed by the Department of National Planning during the year 2019.

- Appraised 03 project proposals and recommendations were submitted to the Department of National Budget for necessary funds to implement these projects.
- Submitted comments for 03 of the Cabinet Memoranda and a Memorandum of Understanding related to the Sports sector.
- Trained to the officials from the Ministry of Sports and other relevant agencies to develop project proposals in line with the New Project Submission Format at the Workshop on "New Project Submission Format for Development of Project Proposals for relevant officers" on 05.07.2019 at Bandaranaike Memorial International Conference Hall.
- Updated the project pipeline on Sports sector for 2019-2021; Medium Term Budgetary Frame Work and participated the meetings relating to Sports sector.

#### 2.7 Education, Higher Education & Skills Development, IT, Science and Technology

#### **Education Sector**

During the year 2019, considerable number of projects, programmes and strategies were introduced to ensure quality, equity and relevance of the Education sector. Major emphasis was placed on establishment of necessary improvements within the school system in order to introduce new policy reforms such as 13 years compulsory education, mid-day meal programme, nearest school is the best school including development of infrastructure and creation of necessary human resources.

Furthermore, many projects and programmes were implemented in order to establish the basic necessary infrastructure developments in all schools including drinking water, sanitary facilities, classrooms, laboratories and lab equipment.

#### Tasks Completed

- Actively participated in the discussions on the way forward of the General Education Sector and proposed education reforms held with the Ministry of Education and other relevant stakeholders.
- Participated in the Steering Committee Meetings and organized and participated in Mission Meetings of Education Sector Development Programme (ESDP) and General Education Modernization Project (GEM)
- Updated the Project Pipeline incorporating new proposals submitted by Ministry of Education
- Prepared 12 observations on cabinet memoranda submitted by the Ministry of Education
  - Appraised 5 new projects and programmes on Education

#### **Higher Education Sector**

The Higher Education Sector further expanded during the year 2019 by increasing the number of students admitted to state universities and by establishment of new Faculties in many Universities, especially Faculties of Technology to open up higher education opportunities to the students who have followed Technology Stream for G.C.E. (A/L). Furthermore, much emphasis was placed on enhancing the employability of the graduates through introduction of new study programmes and modernizing existing degree programmes. In addition, many Universities took initiatives to forge links with the industries, while establishing facilities to encourage research and development within Universities.

During the year 2019, many steps were also taken to streamline non-state higher education institutions and to expand these institutes with a view to expanding access to higher education to students of the country.

#### Tasks Completed

- Actively participated in the meetings with regard to the introduction of loan scheme for offering
  Higher Education opportunities in Non-State Higher Education Institutes for students who are
  unable to enter into state Universities.
- Organized and participated in steering committee meetings and meetings for the missions for major higher education sector foreign funded projects
- Updated the Project Pipeline incorporating new proposals submitted by Ministry of Higher Education and Highways
- Appraised 32 new projects and programmes in Higher Education sector.

#### Skills Education and Youth Affairs

Availability of highly skilled labor force is essential to cater the impressive economic growth of the country. Hence, Government aims to produce 250,000 skilled youth per annum by 2020 including 175,000 NVQ holders with the policy direction of making every Sri Lankan skilled to enable full employment in the global economy while improving their competencies, soft skills, affordability and access for quality vocational education.

#### Tasks Completed in 2019

- Altogether 03 project proposals have been received for appraisal in youth development and skills
  development sectors. Out of the received proposals appraisal reports of the properly justified projects
  has been submitted. The observations were submitted to the Department of National Budget,
  Department of External Resources and to the relevant line agencies.
- 08 observations were submitted to the Cabinet Memorandums.
- Conducted several meetings with officials of skills education institutions, development partners to
  discuss project formulation matters and presentation of required information in the project proposals.
  As well as discussions went through on project prioritization and preparation of public investment
  programme in the sector.
- Also several discussions went through to clarify the way of project formulation in skills development and youth sectors under the newly introduced project submission format.
- Furthermore, major emphasis has been placed on to increase the intake for vocational training especially among school drop outs as well as quality improvement of vocational education combining with the 13 years compulsory education policy.

- Prepare a public investment plan for vocational training and future direction of the sector.
- Conduct an inter-ministerial meeting for the Skills Sector Development Programme. Also several
  discussion rounds conducted with the project monitoring unit officials of the SSDP in the Skills
  Development and Vocational Training Ministry to discuss issues and solutions.

Organized a workshop on NPD- New Project Submission Format to the line Ministries relating to the Skills sector.

#### Information and Communication (ICT) Sector

The information and communication sector has been identified in the areas of Information Technology (IT), Posts and Telecommunications. Information Technology includes revenue earning industries such as Information Technology Enabled Services (ITES), Information & Communications Technology / Business Process Outsourcing (ICT/BPO) and Knowledge Process Outsourcing (ICT/KPO).

The information and communication sector has mainly been identified as knowledge based service sector where the government gives priority to enhancing ICT facility, access to information and communication, improving e-Governance and regulatory facilities while the private sector plays a dominant role in providing services and related infrastructure aiming to upgrade the systems to the international standard. Enhancing safety measures of the websites and activities taken for reduce the emerging cyber-crimes are found to be the most prioritized projects in this sector for 2019.

#### Tasks Completed

- Appraised 03 new projects and programs submitted by the relevant line ministries.
- Prepared the Project Pipeline for the ICT, Postal and Mass Media sectors.
- Prepared observations on Cabinet Memoranda and policy papers submitted by the Ministry of Telecommunication and Digital Infrastructure, Ministry of Postal Services, Ministry of Mass Media and Parliamentary Reforms. Accordingly submitted total of 04 Cabinet observations for Cabinet Memoranda.
- Preparation of the ICT sector note and investment table for the Public Investment Programme
- Organized and participated in meetings for the missions in ICT and Media sector
- Further developed and modified the project on Data Management System for the National Planning Department. Preparation of the proposal, granting the approval, creation of the data entering platform and coordinating the ICTA and NPD for the initiation of the software
- Participated and provided inputs to the programs, workshops and brainstorming sessions conducted by the Ministry of Information and Telecommunication Technology, ICTA and SL/CERT
- Organized a workshop on NPD- New Project Submission Format to the line Ministries relating to the ICT cluster

#### Science, Technology and Research

Development of Research and Technology to the world standard is one of the major targets of the government. High tech industrialization leads to rapid economic development of a country. The government has taken several steps to promote high tech industries in the country to improve quality, productivity and competitiveness of local firms. Research and Development on high tech fields including nanotechnology, biotechnology and Mechatronics have been added a value to many industries such as food processing, tissue culture, fertilizer and mechanical engineering.

#### Tasks Completed.

- Appraised 08 project proposals and submitted observations to the Department of National Budget and to the Department of External Resources.
- Prepared the Project Pipeline for the Science, Technology and Research sector.
- Prepared observations on Cabinet Memoranda and policy papers submitted by the Ministry of Science, Technology and Research. Accordingly submitted total of 06 Cabinet observations for Cabinet Memoranda.
- Several discussions were conducted on the development of effective project proposals for the agencies under Ministry of Technology and Research such as Industrial Technology Institute, National Institute of Fundamental Studies and SLINTEC.
- Organized a workshop on NPD- New Project Submission Format to the line agencies of the Ministry of Technology and Research

#### 2.8 Regional Development, Tourism and Social Protection

#### **Regional Development**

Enhance the living standard of community to a decent level by identifying regional potentials, uniqueness and diverse nature of resources in respective regions are the policy element of Regional Development Sector. The sector is closely linked with other national level development initiatives since it is a cross cutting sector.

Regional Development Sector highlights the importance of sustainable utilization of resources available at regional level for the development of the country. Current economic growth, human development and social indicators are need to be addressed in regional development perspective. Most regional development activities come through regional development ministries.

Regional disparity is one of key issues which need to be addressed as it is closely linked with living standard, HDI indices, and the level of industrial, agriculture and infrastructural development. This has been given a high priority by the successive governments after independence. Accelerated Mahaweli Development Program, District Development Committees, Establishment of Provincial Councils, Gam Udawa, Integrated Rural Development Program, Regional Economic Advancement Program, Gama Neguma, Pura neguma, Gamperaliya are some of major key initiatives implemented in the country to address this issue.

#### **Special Activities**

- Appraised 22 project proposals.
- Submitted 06 cabinet observations for the cabinet memoranda.
- Updated Regional Development Sector in Public Investment Programme.
- Submitted observations to the Department of the National Budget, Department of External Resources and relevant line agencies.
- Consultation to the World Bank Local Development Support Project.

#### **Tourism Sector**

Tourism sector recognized as a high priority industry and it remained as a one of major foreign exchange earner in Sri Lanka economy contributing US\$ 4,381 million in 2018 with 2.3 million tourist arrivals. The New Tourism Strategic Plan (TSP) 2017-2020 was introduced to facilitate Tourism Vision 2025 and helps achieve the United Nation's SDG goals on Tourism.

The government plans to develop tourism sector according to the new tourism strategic plan which will aim to establish Sri Lanka as high-value tourist destination reflecting Sri Lanka's natural and cultural heritage, while making the industry socially inclusive and environmentally responsible and encourage the private sector to attract tourists from new markets and to offer new products with high demand among local and foreign tourists. Further, government policies also focused more on PPP projects with the private sector to develop tourist attractions as well as tourism infrastructure. The Government has identified sites in several location in the country that have great potential to be popular tourist attractions such as Dedduwa ecotourism area and the Cultural Triangle Tourism Expansion Project, heritage buildings in the Forts of Colombo, Galle and Matara, golf courses in Koggala and Matara, and the Koggala seaplane museum, Kuchchaweli and Kalpitiya as possible projects. There were ongoing projects such as development of the Bogambara Cultural and Tourism Centre and the Mattala Tourism Zone. This would be more promising for achieving upscale tourists with high spending capacity.

In addition, the government decided to implement Sustainable Tourism Development Project to address the prevailing issues of tourism sector by developing tourism related infrastructure (Infrastructure development of popular and unpopular destinations), train 10,000 NVQ level skill labors, and provide assistance to tourism related SMEs and institutional development.

#### **Special Activities**

• Appraised 1 project proposals and submitted 03 cabinet observations for the cabinet memoranda forwarded by the line ministries.

- Upgraded Public Investment Programme, related to Tourism sector.
- The observations were submitted to the Department of the National Budget, Department of External Resources and relevant line agencies.
- Consulted to the World Bank Sustainable Tourism Development Project.

#### **Social Protection Sector**

The government puts its whole effort to formulate a comprehensive unified strategy for the whole social protection sector and to implement specific social protection schemes for all necessary segments of the society including women, children, elders and disabled person to improve their living condition and empowering them to contribute to the development of the country. The line Ministries; Ministry of Primary Industries and Social Empowerment and Ministry of Women and Child Affairs are the key Ministries that are responsible to ensure the well-being of vulnerable segments including Children, Disadvantaged Women, Elders and the Disabled persons.

#### **Tasks Completed**

- Preparation of Appraisal Reports for Project Proposals and Preparation of Observations to the Cabinet Papers appraisal reports for 10 project proposals were submitted to the Department of Budget and the relevant Ministries. Observations for 8 Cabinet Memoranda that were submitted by the relevant Ministries were prepared.
- **Review and Formulation of Policies** Child Care Policy was reviewed and observations were provided
- Provided Observations for "Assessment of the Social Protection System in Sri Lanka" and Human Development Report (Draft)"
- Represented the Department of National Planning in Meetings and Workshops attended to the Steering Committee Meetings and Progress Review Meetings conducted by the relevant line agencies of the Social Protection Sector and provided necessary inputs to uplifts the Social Protection Performance.

#### 2.9 Public Management and Governance

The main strategy of the public management is "transforming management methodology and administration system enabling to provide efficient client friendly service while eliminating bottlenecks of the public service through introducing new management practices and administrative system whilst increasing productivity with the use of modern technology".

The regular improvement of the public sector of the country in institutional, human resources and productivity of service providing is essential for the efficient and effective delivery of public service. The government recognizes the significant role that the public sector plays in facilitating the private sector to engage in development activities. Therefore, it is very important to focus on improvement of capacities of both human and capital for efficient and effective public service. Public Management and Governance cluster of the department covers mainly 5 areas: Public Administration, National Security, Judicial sector and External Affairs including 25 "Special Spending Units". The Department of National Planning contributed to improve the sector in many ways during the last year as described in below;

- The approval has been given for 29 project proposals for implementation and recommendation letters were sent to the Department of National Budget and the Department of External Resources.
- 10 Cabinet observations were submitted to the Cabinet received from various ministries which are relevant to the Public Management Cluster.
- Attended the Steering Committee Meetings and progress review meetings conducted by relevant line agencies of the sector and provided necessary inputs to up lift the sector performance.
- Provided technical inputs to the relevant ministries in formulating the respective policies and strategies.

#### 2.10 Decentralized Capital Budget

2077 project proposals amounting Rs.278, 272,000 were recommended under DCB submitted by 29 National List parliament members and forwarded to Ministry of National Policies and Economic Affairs.

  - Some expected projects were not implemented due to change of government priorities.
  - Some of the projects were phase out due to limited fiscal space.
